##### 2.4.1 Percentage of full time teachers against sanctioned posts during the last five years

- The institute offers B. Pharm, Pharm D and M. Pharm programmes in five specialization subjects, Pharmaceutics, Pharmaceutical Quality Assurance (PQA), Pharmacology, Pharmaceutical Chemistry and Pharmacognosy.
- The Programmes are approved by AICTE, Pharmacy Council of India and Savitribai Phule Pune University.
- The institute adheres to the norms prescribed by AICTE and Savitribai Phule Pune University for appointment of teaching faculty.
- As per the AICTE, the full time teacher: student ratio of 1: 15 is required.
- The numbers of posts to be filled are approved by management in General Body meeting. As per the norms of Savitribai Phule Pune University, the vacancy for the faculty positions is advertised and after the interview process the posts are filled. The interview process is conducted by staff selection committee appointed by Savitribai Phule Pune University and the complete process is as per the Savitribai Phule Pune University norms. The recruited faculties are approved by Savitribai Phule Pune University.
