

BETWEEN

Core Analyticals Private Limited, Shop No. 1 to 4 ,Boraste complex, Behind Hotel Manoranjan, 10th mile, Jaluke, Nashik Maharashtra 422101 through its owner/GM/CEO/Director which expression shall unless repugnant to the context of meaning therefore include its successor and permitted assignces of the FIRST PARTY

AND

M.G.V.'S Pharmacy college Panchavati Nashik and represented through its PRINCIPAL which expression shall include its successors in the office and permitted assignees of the SECOND PARTY

The First Party, represented by Mr. Taresh Patil, Director, Core Analyticals Private Limited.

AND

The second party represented **Principal**, **M.G.V.'S Pharmacy college Panchavati Nashik.** In order to establish and maintain scientific research and teaching relationships between the two institutions, make preliminary agreements for sharing the instrumentation facilities between two institutions for their teachers and students.



Now, Therefore, The First and Second Party have intended, agreed and consented to the following terms and deeds in pursuance of the common intent:

- ➤ The first party shall make available HPLC, GC, UV-VIS, Dissolution, Disintegration, Friability tester, IR analysis and others to second party for sample analysis or training purpose or guest lecture or workshops whichever will be as per requirement. However, the cost of specific consumables will be borne by the second party.
- > The second party shall make available the required spaces to first party for training purpose whichever will be as per requirement. However, the cost of specific consumables will be borne by the first party or with mutual consent.
- > There shall be an exchange of students/ faculty members for training purpose. The duration of exchange visits will be determined by mutual consents between both the parties.
- > Both parties shall provide certificates of the training for all training programs (conducted, if any) to successful participants.
- ▶ Both parties shall seek feedback from each participant of training program (if conducted) about overall quality of program, resource persons, etc.
- > The registration fee for training program/ charges against availing instrumentation facilities for sample analysis shall be decided and determined by mutual consents between both the parties.
- Both parties shall provide all necessary infrastructural facilities such as classroom with projection facility, laptop, internet connection, to resource person during training program.
- > It is the responsibility of the individual from both the parties for any breakage or damage to any equipment or instrument during the analysis in the respective laboratories.



- > The MoU may be terminated at any time during the currency of its period of validity through mutual consent after 30 days, notice from wither side in this regard.
- > The parties of this MoU undertake to treat as CONFIDENTIAL AND PRIVILEGED information of the other institutions, which is so classified in advance. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.
- > This MoU will be effective when signed by both parties and shall remain valid for 03 years term from the effective date which may be extended, from time to time, with mutual consent of both the parties.
